Important accreditation information:

HOUSE RIGHTS: The house rules of the home club apply. Reference is made to section A.2.8. of the implementation regulations for the media guidelines.

PROVISIONS: Accreditation as a print/online journalist only entitles the holder to use the workstation allocated by the home club in the media stand. Workstation assigned by the home club in the media stand and - depending on capacity - access to the mixed zone and participation in the post-match press conference. Access to the mixed zone and participation in the press conference. The accreditation does not entitle the holder to enter the interior of the stadium. In exceptional cases, the home club may, after timely advance notice grant temporary accreditation for certain zones of the spectator area.

With an accreditation as a print/online journalist, it is permitted to report on the respective match in text form in newspapers, magazines and other printed publications and/or in the respective associated online presences or independent online media, im by way of live or near-live reporting in the period between the kick-off and final whistle of a match, but only in the form of a written live ticker. The creation of audio recordings in the mixed zone (e.g. with a dictation machine) is permitted, but they may only be used in text form.

Accreditation on the match day does not entitle the holder to create stadium images using smartphones, tablets or other suitable recording or recording devices and to utilize them editorially and/or commercially or to publish them in any other way, e.g. via private social media accounts, beyond the scope of the work and tasks associated with the respective accreditation to publish them in any other way, e.g. via private social media accounts. The taking along of a personal, professional technical equipment (e.g. photo and/or video camera), unless this is necessary for the fulfillment of the accreditation is not permitted and may be prohibited by the home club.

DEADLINES: The completed accreditation form, including its attachments, must be received by the respective home club by 3 p.m. at the latest on the previous Monday before weekend match days and by 3 p.m. at the latest on the Tuesday of the previous week before weekday match days (Tuesday/Wednesday). As a rule, accreditation will no longer be granted after the deadline. Special accreditation deadlines apply for relegation matches and the Supercup.

LIABILITY: The liability of DFL e.V., the DFL, Sportcast and the clubs, their representatives, employees and vicarious agents for damages suffered by the accredited media representatives is excluded, unless there is a breach, at least through negligence, of a material obligation incumbent on DFL e.V., the DFL, Sportcast and the clubs, their representatives, employees or vicarious agents or an obligation whose fulfillment is essential for the proper performance of the activities of the accredited media representatives in the stadium, or the damages are caused by gross negligence or intent. Mandatory statutory liability, in particular under the German Product Liability Act and for injury to life, limb and health, remains unaffected.
